COOLED TRANSPORTED SEMEN ADDENDUM

1. 2010 Contract Stallion Service Fee Balance must be paid in full prior to ordering first semen shipment.
2. Signed and fully executed contracts, copy of mare=s registration papers and completed CTS Apre - shipped@ information form must be on file at Pieper Ranch prior to first shipment.
3. First Shipment Fee must be paid prior to first shipment. Pieper Ranch, Inc. will be responsible for costs incurred including courier from Pieper Ranch, Inc., airline counter to counter service, Fed Ex or UPS. Pieper Ranch, Inc. is not responsible for any courier charges at the receiving end. Each additional shipment will incur another shipping fee, with a limit of four (4) shipments per breeding season, per mare.
4. We do not charge a deposit on shipping containers however we ask that the Equitainer and all internal parts must be returned at mare owners= expense **immediately** following insemination of the mare. Mare owner agrees to reimburse value of any shipping container or parts that are not promptly returned. Please return Equitainer by Fed Ex or UPS so that you have tracking information in the case of missing parts. Any Equitainer not returned within one week of shipping date may be charged a fee of \$25.00/day if the delay is a result of neglect to return. Semen Evaluation paperwork and Stallion Owner (pink copy) of AQHA Collection/Insemination Certificate must be returned to Pieper Ranch, Inc. with the Equitainer or by mail. AQHA white copy of the Collection / Insemination form must be sent directly to AQHA and is the responsibility of the mare owner or their agent.
5. Semen will be collected and shipped on breeding days only - please refer to Pieper Ranch, Inc. Collection Days Calendar chart.
6. Mares on the premises of Pieper Ranch, Inc. have breeding priority on any given breeding day; therefore we make **no guarantee** cooled semen will be available for a specific day.
7. A request for shipment of cooled transported semen must be made no later than **12:00 NOON** the day preceding shipment. Cancellation of shipment must be made prior to **5:30 a.m.** on the day of shipment or the shipping fee will be charged. (We collect the stallion, package semen and have courier service arranged by 6:00 a.m. on breeding days).
8. Return breeding will be honored as per the stallion contract however mare may be required to come to Stallion Managers' facility rather than through transported cooled semen. Mare must arrive the following season only and rebreed service fee must be paid. In lieu of this rebreed privilege, Stallion Manager may elect to refund the Stallion Service Fee, less the Booking Fee and Shipping Fees.
9. All other terms of the regular Stallion Service Contract shall apply.

Please read our CTS Information letter and CTS Collection Days Calendar for further information regarding policies. The key to breeding your mare with cooled transported semen is very careful planning, experienced reproductive mare management and conscientious communication and coordination with the Stallion Manager.
